- FaDDS is preparing for Day on Hill and more information will be out soon.
- Dallas County Public Health with the Maternal Child Health Program has earned the Iowa Family Support Credential which is good for 5 years.
- There are transportation vouchers available at Dallas County Public Health to assist with getting to appointments.
- EFR has been collaborating with Zion to provide gambling and addiction education to clients.
- Dallas County ISU Extension will provide Great Beginnings a 5 week class in Perry. Extension may offer an additional class during the day in Waukee prior to March 31. Extension is also offering Strengthening Families evening classes starting January 15 through March 5 in DeSoto.
- The Jewish Federation of Greater Des Moines, just off Interstate 80 has meeting space and an auditorium for use.
- Wildwood Hills Ranch has program for veterans and their families to assist in transitioning to civilian life.
- The Waukee Community Closet has moved to Carefree Lane, next to Saints on Hickman and will be open January 16th.
- NAMI basics training will be held January 10, 2016 at the Ask Resource Center in Johnston.
- VITA sites will be up and running for free tax preparations for those making \$58,000 or less. Locations are in Perry and several sites in Des Moines.
- Parents as Teachers has a waiting list in Dallas County.
- American Lung Association collaborated with Sumpter Pharmacy to provide a smoking education event and it was well attended.
- A list of all the know food pantries was disseminated.
- The Dallas/Boone Mental Health conference will be held at Hotel Pattee April 13. Detroit Lion's Quarterback Eric Hipple will be the guest speaker and parents of Autumn Elgersma, who died in a child care setting.

Early Childhood Updates/Information

- [Paper Tigers](#) and [ACEs](#) Presentations - 1st Five, EFR, 4 R Kids, Generation Wellness, DCCAC, and DCAT/CPPC are collaborating together to provide viewings in Dallas County. A tentative date has been selected, March 6 at Lutheran Church of Hope Waukee in the evening and will provide a free meal and the target audience is the faith community, school personnel, and community members.
- Information was shared regarding the recent data that was collected from the school regarding preschool experience rate. The overall rate for the four county area is 89.9% and the Dallas County rate is 87.2%.
