Agency Sharing

- Dallas County Extension will be offering Great Beginnings August 28- October 2, 2017 from 6:30-7:45 at the Waukee YMCA. Strengthening Families will be October 1 - November 12, 2017 from 5:30-7:30 at the Waukee Elementary.
- Crisis Intervention & Advocacy will have its 2nd annual car show in Bouton September 30, 2017 from 12:00-5:00. They also shared that starting July 1 2017 a new civil protection order can be filed. This is a new development for Iowa.
- AmeriHealth Caritas will be hosting a baby shower August 30, 2017 from 5:30-7:30 at Des Moines Community Wellness Center in Des Moines. Anyone expecting a child is welcome to attend.
- Dallas County Public Health will be hosting a baby shower September 19, 2017 at 4:00 at the First Christian Church in Adel.
- Employee and Family Resources will be providing gambling education in at the Dallas Center Grimes middle school this fall.

Early Childhood Updates/Information

- The 4 R Kids ECI Area board is looking for board members, preferably a male. The Board has issued a request for renewal process for existing contract holders and [programs](#) started July 1, 2017.
- The group reviewed the [Dallas County Early Childhood services map](#) and made noted changes. All changes are to be received to Deb Schrader at 4rkidseci@gmail.com by September 1, 2017.
- Future presentations were discussed such as 2-1-1, Resiliency viewing, and Paternity Affidavit.
- Samra Hiros is the new contact for American Lung Association. Clients who are in a Managed Care Organization (as the majority of Medicaid patients currently are) have to go through their MCO for smoking cessation resources and can no longer utilize Quitline Iowa. The fee-for-service Medicaid population can still utilize Quitline Iowa. All clients in an MCO have to go through their MCO for smoking cessation resources starting July 1, 2017. Samra shared the FY18 work plan with the group and it is attached to the minutes.

Dallas County Children's Advocacy Council Updates/Information

- The 1st fundraiser was July 22 from 5:30-9:30 at Penoch Winery. Sponsors of the event were Dallas/Boone Community Partnerships for Protecting Children, Hawkeye Breeders, Providence Place, Raccoon Valley Bank, Parenting Way Inc, and Alley Auto/Jim Book. The event took in \$2,170 and after expenses the net profit is \$1,290. Ideas for next year include having the event on Friday night and a band that has a good following, Abby Normal was suggested. It was noted that many businesses set their donation budget in December and marketing would need to begin early.
- The Dallas County Coalition discussed ideas as to what the funds should be used for. It was recommended to utilize funding for pinwheels and purchase Second Step curriculum for Crisis Intervention & Advocacy. There was question as to where the pinwheels could be stored as they take up a lot of space.
- The Dallas County Children's Advocacy Council has 2 positions available, contact Dena Owens for more information.
- The FY17 Executive Summary was shared with the group. \$37,780 was expended, with 42 children and 55 families served with 36 group parent education sessions conducted by Dallas County ISU Extension, 23 families and 40 children served with 43 parent education sessions were conducted by Partners in Family Development, and 585 children served and 90 education sessions conducted by Crisis Intervention & Advocacy.
- Dallas County child abuse data was shared with the group. Dallas County ranks 89th for rate of abused children in Iowa.
- The FY19 RFP from DHS/Prevent Child Abuse Iowa is anticipated to be out January 2018. Due to anticipated changes regarding what can be funded it is difficult to plan for services prior to the RFP.

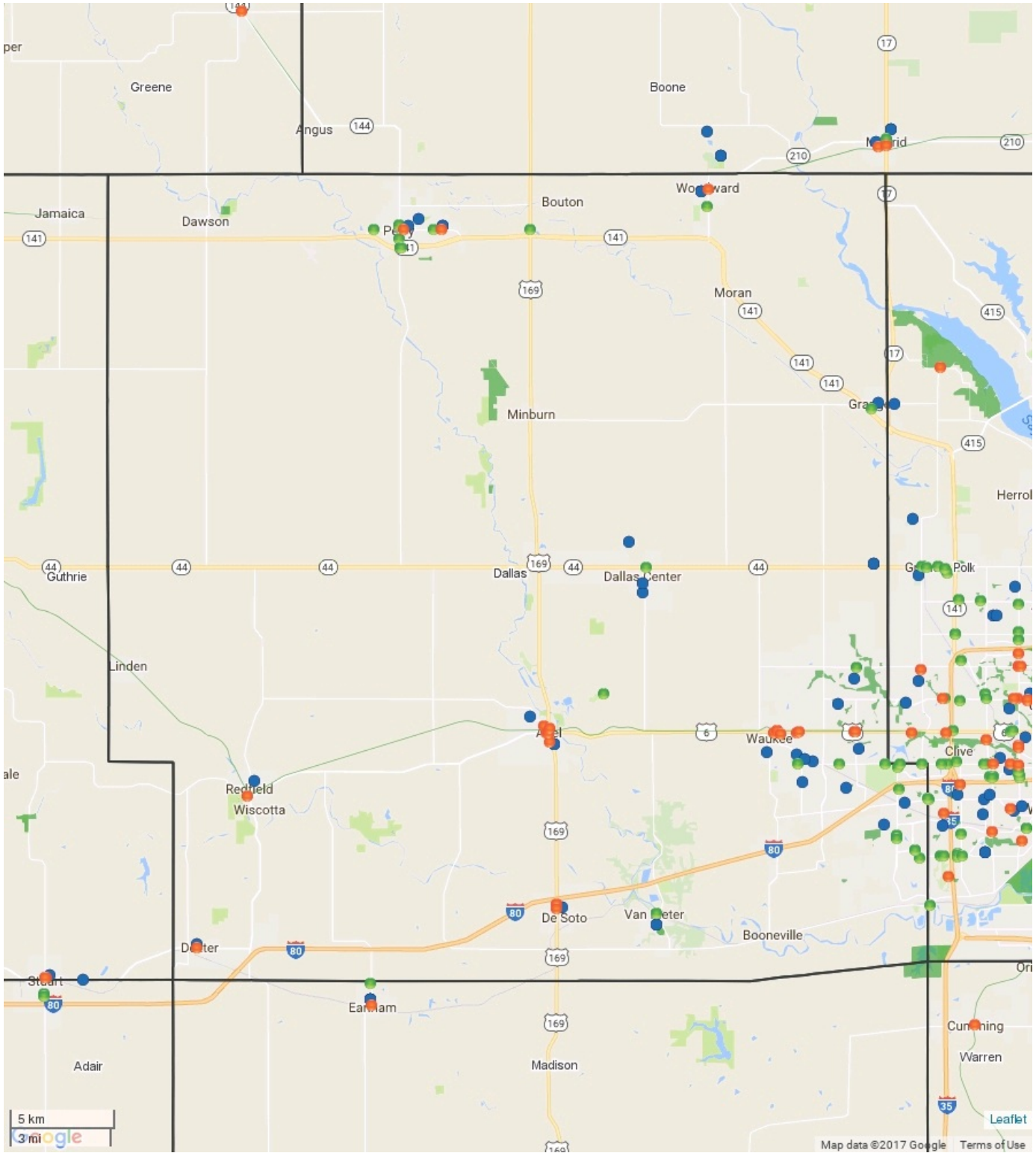
