<b>Purpose</b>	The Madison County Early Childhood Committee is the standing advisory committee for the 4 R Kids Early Childhood Iowa Area Board. The Board may refer specific issues/tasks to the committee. Tasks may include but not limited to - provide expertise in fields of health, human services, early care and education; suggest public policy; provide guidance on community needs and issues; and advocate for the early childhood issues. Recommendations from this committee are presented to the 4 R Kids ECI Area Board for action.	Prevent Child Abuse Councils are in Iowa Code section 235A.1 and is defined by 441 Iowa Admin. Code ch. 155. The Madison County Child Abuse Council is obligated to meet regularly, assess the needs of their community, and propose funding for projects that will meet the local area's needs as they relate to the prevention of Child Maltreatment. The following representatives are to be included on the council and are required: Education and/or Early Childhood Education, Public Safety or Law Enforcement, Medical and/or Mental Health, Domestic Violence, Substance Abuse, and Parents.	Madison County CARES is comprised of community members and agencies which strive to make each community better for Madison County families. The group discusses needs and concerns within the county and takes action to address the needs and concerns when necessary. The group also collaborates with agencies, schools, etc. in each community to provide an annual Drug Drop, the Every 15 Minutes program, a Health, Wellness and Safety Fair and Family Fun Day all geared towards bettering Madison County.	1 <sup>st</sup> Five Coalition Meetings are intended to provide professionals and community member's information about services available to children and families in Madison County. A different agency will present on services they provide each meeting.	The CPPC Steering Committee is made up of 12 voting members and a host of community providers. Though all give valuable input, only the voting members act as an advisory board to the DCAT Governance Board. The voting members read all funding proposals and make recommendations to the Board. The group as a whole discusses issues/concerns within the communities as they arise. If it is deemed necessary that action be taken, the voting members make a recommendation to the Board for things such as funding, new programming, etc.
