<b>Purpose</b>	The Early County Early Childhood Committee is the standing advisory committee for the 4 R Kids Early Childhood Iowa Area Board. The Board may refer specific issues/tasks to the committee. Tasks may include but not limited to - provide expertise in fields of health, human services, early care and education; suggest public policy; provide guidance on community needs and issues; and advocate for the early childhood issues. Recommendations from this committee are presented to the 4 R Kids ECI Area Board for action.	The Child Abuse Prevention Council is the governing board for the organization. Fifteen members from throughout Warren County representing various sectors of the community are elected to serve two-year terms as board members. There are written by-laws, officers, and job descriptions. The Council is responsible for agency/program planning, monitoring, evaluation and financial oversight. Each meeting includes financial, administrative and program reports as well as special initiatives/projects such as fundraising, community awareness, Child Abuse Prevention Month, etc.	The Family Care Team is comprised of community members and agencies which strive to make each community better for Warren County families. The group discusses needs and concerns within the county, shares resources, and troubleshoots specific issues.	The CPPC Steering Committee is made up of 12 voting members and a host of community providers. Though all give valuable input, only the voting member's act as an advisory board to the DCAT Governance Board. The voting members read all funding proposals and make recommendations to the Board. The group as a whole discusses issues/concerns within the communities as they arise. If it is deemed necessary that action be taken, the voting members make a recommendation to the Board for things such as funding, new programming, etc.	Raising awareness for domestic violence issues in Warren County, collaboration with law enforcement in Warren County to better serve victims and ensure their needs are met, raising funds to support victims in various ways.	To support the overall Health, Well-being, and Quality of life in Warren County, IA. Current focus on Mental Health, Collaboration between communities, and Healthy Food Access. Subcommittees report on progress, additional and current needs of the community are discussed and updates are given on events happening in Warren County.
