**4 R Kids:**

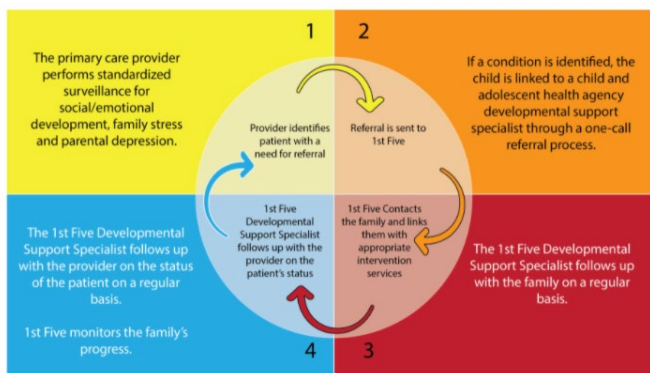
- Board Memberships- shared open position in Madison County and directed to 4 R Kids website for additional information.
