 - The FY24 grant awards for early childhood programming was provided. All contracts were renewed from the previous year. This is the last year of a 3 year grant cycle. There will be competitive grant cycle for FY25.
 - The UpLift report was provided, 10 Warren County participants were chosen to receive \$500 a month for 24 months for 2 years in this research project conducted by the Harkin Institute.
 - Medicaid and Hawk-I guidelines were reviewed.
