### Presentation

A presentation about Your Life Iowa, mainly around the gambling section was provided to the group.

### Introductions/Announcements

- Zion –Lisa Carstens, Certified Prevention Specialist (IPN Grant) from ZION Integrated Behavioral Health Services We are entering the fifth and final year of the Integrated Provider Network (IPN) Grant. Utilizing the Strategic Planning Framework (SPF) Model, this is the evaluation year. I have included a document that explains the SPF for your review. As a reminder, the three priority areas for Madison County are Adult Binge Drinking (ages 25-65), Youth Marijuana Use (ages 12-20), and Problem Gambling (ages 21+). Since September is Responsible Gambling Education Month, Lisa gave a short presentation on the Iowa Department of Human Services Your Life Iowa Website. In particular, she shared the section on gambling and the resources available, including 1-800-Bets Off.
- **Opioid funding** Adair County Board of Supervisors will be receiving \$197,083 in Opoid settlement funding to use for evidence-based programming.
- **CPPC Conference** will be November 15, 2023 in Des Moines.

- 4 R Kids Board There is an opening on the board for a Dallas County representative.
- The FY24 executive summary was shared with the group.
- The family support referral map was reviewed and changes made.
- The Madison County early childhood services map was reviewed and changes made.
- An update on the HHS Service Delivery System Assessment was provided. Recommendations to changes to 19 different programs will be available around October 15, 2023.
- The Iowa Boards, Commission and Council recommendations were reviewed. There were 259 boards reviewed, the state ECI board will remain, several others will be eliminated or merged/consolidated. The recommendations are required to be to the Governor by September 30, 2023.
